# North Texas Division, USFA 2016 Annual Meeting Minutes

May 14, 2016 Fencing Institute of Texas

### 1) Call to order Brenda Waddoups

The Annual Meeting of the North Texas Division, USFA (NTXD) was called into order at 4:07 PM on May 14, 2016 at Fencing Institute of Texas (FIT) 11482 Luna Road, Suite 100 Farmers Branch, TX by Brenda Waddoups.

A quorum was declared.

NaRaye Williams gave us a break down of the division's financials. We do have excess funds and will need to provide some ideas on what the division can fund. **Action Item: for Ovy-** Get rid of the old metal strips.

Brenda Waddoups stated the division still needed to work on a sabre and foil referee program. The division should be good with the number of epee referees. The NTXD is establishing a policy of reimbursing the difference between a regular USFA

membership and a professional membership, if the referee test has been passed. She also stated that Safe Sport training will be available online and that all professional members will be required to take the training in addition to passing the background checks.

Brenda Waddoups presented a verbal report.

**NAC DV1** She shared some news from committees of the USFA. The Tournament Committee is proposing a two-day DV1 Epee event at a NAC this year. How it will work: the top 34 fencers if those registers (based upon national points) move to the second day of fencing. The rest of the field with fence the first day as regular, through pools and through direct eliminations. The top 22 from the first day of fencing will be entered to the second day with the 34 making a field of 56. They will proceed to fencing the DV1 event as regular. The losers from day one will fence on day two in the DV1A event.

The national epee coach is pushing for this. If the coach does not get this new configuration, he will not award any points.

**New Sabre Placement and Timing** Chris Slaughter shared that the placement will help eliminate a lot of simultaneous calls. The price of the new chips in the boxes is a concern.

**December NAC Foil** Brenda also shared a proposal to move the DV1 Foil out of the December NAC and making it a stand-alone competition. This is because the World Cup competition is scheduled the same weekend.

Motion to Accept: Lockette move to accept that this is stupid... NaRaye seconded.
